November 16, 2020

Call to Order: A regular meeting of the Board of Governors, TBDBITL Alumni Club, Inc., was held via ZOOM virtual media, on November 16, 2020. The meeting commenced at 7:03 pm with President Zacke Naughton presiding.

Adoption of Agenda: A motion was made to adopt the agenda; **motion carried by unanimous consent.**

Adoption of Minutes: A motion was made to adopt the minutes from the Board Meeting on September 21 and the Annual Membership meeting September 26 meetings; **motion carried by unanimous consent.**

President's Remarks. In recognition of Veteran's Day, President Naughton thanked those who were military veterans, or those in their families who have served our country. He also reviewed about his attendance at the OSU Alumni Association Leadership Symposium. Secondly, Melissa Trahyn introduced herself as our new board member at large, sharing about her college and personal background. All welcomed her to the board. Lastly, President Naughton provided chairman position updates: a) there are two new Awards Committee chairman with the retirement of Mr. Beis: Ms. Pallard as the lead and Mr. Montgomery as the assistant; b) Miss Smallwood had submitted her resignation from the Publicity Chairman so that she can focus on her student teaching and career. She will remain on the board for her at-large position. The Board wishes her well; and we now have a current vacancy for the Publicity Chairman. If anyone is interested, please notify President Naughton.

OSUMB Report. Dr. Hoch provided an update that the students have adapted well this semester with all of the changes experienced. There have been students who've had to quarantine, and there were few actual illnesses. There have been two halftime shows, one ramp and one Script Ohio that have been recorded; all performances are being shown in the Stadium on game days, and they are available on line prior to Buckeye kickoffs. The final show is being prepared for the Michigan game. Cheer groups, pep bands, and even a request from Fox Sports have kept the students performing around campus. Dr. Hoch thanked everyone for providing meals for the band, especially to Ms. Smith and the continuance of Adopt-A-Row. He also thanked Ms. Graf for the Pizza Party efforts.

OSUAA Report. Mr. Little expressed gratitude, on behalf of the OSUAA, for all of the dedication and contributions that our Club undertakes. He reported that due to the pandemic, the OSUAA is down approximately 500 events and 42,000 donors so far compared to last year. He encouraged virtual participation, and thanked the Club for trying new events. Mr. Little suggested creative collaboration with different clubs and trying new events. He also provided a link to a Mask fundraiser event where \$4.00 will be donated to your identified fund. It is: buckeyefunder.osu.edu/project/21724. TBDBITLbit. Dr. Ebert referenced the latest Alumni Magazine that had a quiz regarding TBDBITL and some of the answers that she missed. This included information and history about the Snow Bowl and the half time show. Pictures from the show were included along with interesting stories about that day and the band's performance.

Committee Reports.

- 1. Family Events.** Ms. Diemand has been working on a story time for children; is looking for appropriate books, and is trying to locate a book that highlights the marching band. She has secured a celebrity reader, and this most likely will occur after the holidays. Information will be sent out after January.
- 2. Outreach.** Mr. Hutchinson reported about the meeting with Honorary Member historian Jack Park; how he was so engaging; and that it was a beneficial event. Mr. Park has a book for purchase, "Buckeye Reflections", and is willing to take \$5.00 off the price, along with contributing \$5.00 to our funds. - 3. Adopt-A-Row.** Ms. Smith shared the latest update where her team was able to serve the OSUMB in person 2 weeks ago. Band members were able to sit outside together, socially distanced, and they enjoyed the time together. This Monday will be the last meal provided. There are some funds left over, and if the band would get to participate in a bowl, it could be used for that purpose. Amazingly, over \$12,000 was raised this year to share for the band members' meals.
- 4. Pizza Party.** Ms. Graf shared how this year, a packet has been created for each student. Contents include a letter from the TBDBITL Club; a Papa John's pizza voucher (that can be used at 25 central Ohio locations); a TBDBITL bumper sticker; and a TBDBITL notebook. These 252 packets will be delivered on Friday, November 20, to all the students and the directors. It was decided to wait on distribution of TBDBITL ball caps.
- 5. Special Events.** Mr. Smith reported that HyperFriday and the Buckeye Cruise for Cancer are both tentative, but that the cruise looks 99% sure that it will occur. HyperFriday has 2 vendors that wish to have the band perform (Nationwide Children's Hospital and Buckeye State Bank). At this time, there are 30 participants for instrumentation. Masks and bell covers have been ordered for all registered. Call Mr. Smith if you plan on attending. **Here

New Business.

- 1. Financial Statement and Endowment Contribution.** Mr. Kirkendall reminded the Board that if any members require reimbursement, to include BOTH your address and phone number, due to using Huntington Bank "bill pay" system. The account for First Financial has been officially closed. See the attachment for references, and the \$12,000 raised for Adopt-A-Row was highlighted. The endowment fund was discussed, regarding changes and donations that have been transitional in 2020 from the pandemic/inability to have our usual performances/fundraisers. Our usual pledges have been \$50,000 per year, but there was discussion about submitting a smaller donation due to this. A motion was made by Mr. Kirkendall to contribute \$5000 to the endowment fund at this time; the motion was seconded by Mr. Smith. After discussion, the motion carried by majority, with only 2 abstentions.
- 2. Ms. Graf** shared that the Script Ohio Club has just sent out their information for donations.
- 3. Miss Gina Lawhon** provided an update about the Time Capsule project. She has personally called people and used social media to remind/encourage members to submit their stories. Over 100 members have been notified, and 21 video submissions have been received. The new deadline for submission will be in the next 2 weeks. President Naughton will place a reminder in the next Postmaster email.

President Naughton** shared that there will be an opportunity to participate in a Skull Session one hour before the Michigan game, where Dr. Hoch, Ms. Reik and Mr. Drouillard will be present to talk about the year and to take questions. The Script Ohio committee held its most recent meeting on Thursday, October 8, 2020 at 7:00 PM virtually via Zoom, with nine committee members in attendance.

1. Election of officers for the 2020 - 2021 year:

- A. Chairman: Greg Daniel
- B. Vice-Chairman: Tom Trinter
- C. Secretary: Pete Boriin
- D. Membership: Shelley Graf
- E. Premiums & general sales: Pete Boriin
- F. Distributor of TBDBITL scholarship letters: Judy Baird

2. Under the chairman's report, we discussed:

- A. The SOC annual membership & membership thank-you letters, as well as the merchandise form, are done, and the committee took time to be sure that the format and content are correct. Pete Boriin has sent the OSUMB 2020 roster to Ed Franks, who is updating the database & validating all postal addresses so that the annual membership mailing can go out as soon as possible. Susan Scharenberg will assist Ed Franks with the updating of the email database.
- B. Judy Baird will once again author the congratulatory letter sent out to OSUMB recipients of 2020 TBDBITL scholarships. Dr Hoch reported that fifth year OSUMB members have each received \$3,000, fourth year members \$2,500, third year members \$2,000, second year members \$1,500, with the remaining funds to be split among first year members. Dr Hoch confirmed that the drum major received full in-state tuition of \$11,084 for the year.

3. Shelley graf presented updated account balances.

4. Dr. Hoch reported that in 2019, the OSUMB had the largest graduation class ever; that fifth year 2020 members will be granted a sixth year extension to allow them to march again when conditions improve; the band hopes to release a full video show for each home game this year; music is recorded at field level; and that There are no plans for a new CD this fall.

5. The date for the next meeting of the Script Ohio Club committee has yet to be determined.

6. After the meeting, a subcommittee of Pete Boriin, Greg Daniel, Shelley Graf, Alex Nicolozakes and Tom Trinter met via Zoom in order to format an advertisement to be run in the December philanthropic magazine issued by COLUMBUS MONTHLY. The SOC has purchased a one-third page ad, to be located on a righthand page of the magazine. We are hoping that the ad will circulate to a large readership and will replace the Skull Session Program, normally our best recruitment source for Script Ohio Club memberships.

Attachment D: Hyper Active Band Report

The HAB 2020 - 2021 fiscal year began on May 1; to date, the restrictions imposed by the COVID-19 pandemic have prevented the band from performing. Our annual visit to First Community Village, scheduled on the outdoor patio for October 15th, had to be cancelled due to instrumentation issues-- although the chilly temperatures and pouring rain that day would have meant a last-minute cancellation. The organizer at First Community Village and I have agreed to consider a rescheduling in the spring. The HAB has an event pending on Saturday evening, November 21, to play at AJ Angelo's Music Marathon. This event is in an enclosed tent, which makes the use of masks and instrument bell covers imperative. As of this writing, the band numbers are not looking promising. Since our group has members whose ages span six decades, each of them must make the decision which best suits individual health & safety circumstances, and I value a yes response just as much as a no response.

Annual events surrounding the Michigan game—Clintonville Woman’s Club, the pep rally for the patients at Dodd Hall, and the Tuesday evening pep rally at Plank’s—have been cancelled for this year.

I continue to seek safe environments in which to play. Until we can play together in the current reality, it is difficult to judge whether we can do so, especially in an indoor environment. Social distancing between players is unquestionably difficult for a small ensemble such as the HAB, and I welcome and value any helpful input from the band directors with respect to this subject. Currently, the purchase of instrument bell covers is on an individual basis; however, other avenues are under consideration. Until the health risks are mitigated by a vaccine or other factors, the bottom line will always be the personal safety of our members and their families.

As a result, we recommend that you assume at least a 4-week lead time in planning virtual events. Please work with your society liaison to secure a vendor to provide live captions or to submit an exception.
